### Project Implementation:

The FRUITS project is functional in all 229 taluks across the state which would require a qualified technical personnel for its successful operation and management at district level. Hence, FRUITS Project Monitoring Unit, Centre for e- Governance, DPAR (e- Governance), Government of Karnataka invites direct applications from the eligible candidates to work under district administration and support project monitoring unit, FRUITS for operation and management of projects like FRUITS, Crop Survey, e-Sahamathi, Samrakshane(Crop Insurance Portal), e-SAALA (FRUITS-Bank Integration Portal) of the state Government at the District level.

### Role and Responsibilities:

- District Consultant-FRUITS should technically support and co-ordinate with all the user departments, institutions and other stake holders at district level for smooth and effective functioning of all the web and mobile applications viz., FRUITS, Crop Survey, e-Sahamathi, Samrakshane, e-SAALA.
- He/she will be the point of contact for all the stake holders in the district about the use of web and mobile applications and he/ she shall coordinate with the state level FRUITS PMU.
- He/she shall handle all the issues and queries raised (mainly technical) by user departments about the use of these web and mobile applications.
- He/ she shall coordinate with the user departments in extending services using these web and mobile applications with respect to technical issues and requirements.
- Any other IT related work assigned by CeG and/ or the district administration w. r. t. e-Governance projects coming under DPAR (e Governance) on need basis.
- He/she need to travel across the district as and when need arises.
- The selected candidate should report to District Commissioner of the District as well as FRUITS PMU CeG.

### Eligibility:

The Consultant-FRUITS post to be filled on purely contract basis for a maximum period of one year. The candidates with Computer Knowledge, good communication skills and with following education qualification may apply.

### Area of Operation:

The selected consultant/s headquarters would be District headquarters. He/she shall work under district administration. Required to travel to all taluks whenever required as per the advice of the FRUITS PMU and/ or district administration to cater to all the stakeholders like all user departments, institutions, Banks and Cooperative Financial Institutions and others at gross root level who are using the afore mentioned web and mobile applications for extending various types of services to the farmers in a smooth manner and without any hindrance.

### Terms and Conditions

1. The applicants may apply for the Consultant-FRUITS post at district level through SEVA SINDHU portal only
2. Last date for applying through the portal is 30/03/2022
3. All the supporting documents need to be uploaded through the portal only.
4. The hiring of human resources is purely on contract basis.
5. The resources would be hired based on the eligibility and relevant experience
6. The eligible candidates will be invited for interview by the selection committee of the CeG and would be selected based on the merit and knowledge during interview.
7. Local District's candidates would be preferred
8. The contract period shall be for maximum of 1 year from the date of selection and posting. CeG reserves the right to terminate the services of the hired human resource with or without assigning any reason at its sole discretion. The CeG also reserves the right to extend the services beyond one year.
9. The CeG reserves the right to terminate the candidate due to non-performance at any given point of time.
10. The selected candidates would be trained at CeG and deployed to designated districts.
11. The selected candidates will be paid on fixed monthly remuneration as consolidated consultation fee of 30,000/- per month shall be inclusive of all statutory fees, taxes, duties, P.F., service tax, etc., if any. The same shall remain fixed throughout the contract period.
12. The travelling expenses based on the certification by the district administration will be provided along with the monthly payment limited to upper limit (Amount and type of travelling will be intimated later upon selection).
